

REGULATIONS GORDOLA ADVENTURE PARK

Important

To guarantee you a pleasant time, we remind you of the fact that moving from a tree to the other, several meters above the ground **-completely self-governing**, **self-secured and under your own responsibility**is a risk activity which implies the respect of a certain number of rules and compulsory recommendations.

- 1. To be in good **shape**, **not to have heart trouble** and not to have taken substances that may alter your behaviour (e.g. alcohol, drugs, medicines etc). To **feel good** (in order to avoid panic attacks) and not to **suffer from vertigo**.
- 2. To follow the compulsory introductory course (briefing) that instructs you in the use of the installations and in the technique of evolution. To respect the safety conditions that are described and in particular to always be double secured. It is obligatory to constantly be anchored to the safety cable. On each game, 1 person only can go at a time and on the platforms not more than 3 at the same time.
- 3. To scrupulously use the **equipment of individual protection** that is given you after having paid the entrance ticket. To wear suitable clothes in relationship with this activity (in particular wear sport shoes). To tie up your hair and remove all the accessories that can get stuck (e.g. foulards, hats, earrings etc), to avoid taking objects of value (e.g. glasses, necklaces, keys etc) and in general, any objects that could fall while crossing between the trees.
- 4. Not to hesitate to ask for advice, to communicate any difficulty you may have, or to ask us for help at any time. Our saying is: **information, overseeing and help**.

Practising this risk activity:

1. You authorise us to:

- close the routes in case of bad weather conditions.
- exclude those people who risk his/her and other people's life with their behaviour (e.g. not to follow the
 rules and the safety conditions), or who do not respect our observations. In such cases, no refund can
 be asked.
- not to allow people who we judge do not meet the physical and mental requirements needed.
- 2. The Gordola Adventure Park **does not assume any responsibility** for accidents due to your act of negligence and your carelessness of the safety rules; for the loss or damage of personal belongings, or in general for other reasons.

You vouch for your own safety.

Taking into account the specificity of this activity:

- 1. The access to the routes is limited to the opening hours and reserved to the clients with a valid ticket.
- 2. The access to the **yellow** route is authorised to children that are more than **1.20 m** tall, and are under constant **supervision** of a responsible adult.
- 3. The access to the **green and blue** routes is authorised to people that are more than **1.40 m** tall (children must be **accompanied by an adult on the route**). **1 adult every 2 minors**.
- 4. The access to the **other routes** is allowed to people that are more than **1.50 m** tall and weigh less than **130 Kg**.
- 5. We repute that the participation of minors is approved by their parents, whether they accompany or guard the minors on the routes.
- 6. Groups and schools are under their organiser's responsibility.
- 7. All the people on the routes must visibly wear the **bracelet** that proves their right of entrance.
- 8. It is highly recommended not to stop or walk under the games or the platforms.
- 9. It is strictly **forbidden** to leave the area of the park with the safety equipment.
- 10. The safety equipment is delivered to you for 2 ½ hours. Any additional time initiated will be invoiced at 6.- CHF (4 €).

With the acquisition of your bracelet you expressly acknowledge to have accepted and are totally in agreement with these regulations.
